It was my great honor, on behalf of your Negotiating Committee and Executive Board, to announce the ratification of a new agreement with DHL Express. This agreement, winning the largest wage increases in the history of our Union, is a testament to the membership's solidarity, resilience, and courage both during the negotiations, and throughout the COVID-19 pandemic. Your unwavering support of the Union and your fellow workers and members, and your dedicated service to DHL's customers these last four years has been the bedrock of and reason for the success of our negotiation efforts.

In the face of rising living costs, our primary objectives at the negotiation table were laser focused – to improve wages and benefits; to enhance job safety and employee rights; to ensure the long-term financial security of our active members and their families; and to help ALL our retired members live with dignity.

There is now parity among the top wage rate in the PUD and Gateway contracts, and all part-timers and full-timers at top scale will receive annual wage increases which equates to increases of 17% over 4 years. These historic wage increases are supplemented by increased bereavement (funeral) leave, additional holiday pay (Martin Luther King, Jr.), improved jury duty leave, and new C.O.L.A. language to protect your wages from inflationary cost of living increases.

Through your hard work and commitment, consistently prioritizing customer service and exceeding the expectations set for you, we were also able to secure fully paid across the board increases into your Health, Welfare, and Pension Funds, the total cost of which by the 4th year of the contract will amount to more than \$50,000 paid by DHL, per fulltime employee, per year. The Union has and will continue to push hard for more favorable pension benefits for you and your families when you are no longer working. This DHL contract has secured high contribution rates that will deliver strong medical coverage and retiree benefits for ALL members in the Local 295 Health, Welfare and Pension Funds.

Your role in this journey has been and continues to be invaluable. We have achieved milestones that set a new standard for our industry and demonstrates the power of our core principle: Victory through Unity.

I extend my utmost appreciation and gratitude to our Stewards and the members of the Negotiating Committee and Executive Board whose relentless efforts helped to get us here. I also commend the members of the DHL Express negotiating committee for their good faith cooperation and the respect shown for our hard-working members, best demonstrated by the results we achieved at the bargaining table. I also thank our Pitta LLP attorneys for their hard work and wise counsel throughout our negotiations.
